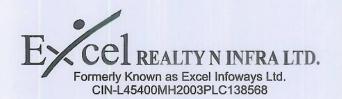

We have reviewed the accompanying statement of unaudited financial results of Excel Realty N Infra Limited (Formerly known as Excel Infoways Limited) for the quarter ended June 30, 2015 except for the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' which have been traced from disclosures made by the management and have not been audited by us.
