Gist of the proceedings of the Annual General Meeting Of Excel Realty N Infra Limited (formerly known as Excel Info ways Limited) held on Friday, September 24, 2021

The 19th Annual General Meeting of the Members of the Company was held on Friday, September 24, 2021 at 11:30 a.m. Video Conferencing (VC)/ Other Audio Visual Means (OAVM). The Meeting was held in compliance with No 14/ 2020 dated April 8, 2020, Circular No. 17/ 2020 dated April 13, 2020,, Circular No. 20/2020 dated May 5, 2020 & Circular No. 02/2021 dated 13th January 2021 and SEBI Circular No. SEBI/1-10/CFD/CMD1/0ER/P/2020/79 dated May 12, 2020 and January 15, 2021 issued by Securities and Exchange Board of India and as per the applicable provisions of the Companies Act, 2013 and the Rules made thereunder.

The following Directors, KMP and Auditors were present in the meeting through Video Conferencing (VC) from different locations:

The Company Secretary welcomed all the Shareholders joining over Video Conferencing. She also informed that this meeting is held in accordance with the MCA circulars dated 8th April, 2020 13th April, 2020 and 5th May, 2020 and Securities and Exchange Board of India circular dated 12th May, 2020 and January 15, 2021 wherein the Annual General Meeting of the Company is allowed to be conducted through video conference or any other audio visual means without having physical presence of members at a common venue. She requested Mr. Lakhmendra Khurana, Chairman & Managing Director to take the Chair.

The Chairman took the Chair and commenced the proceedings of the meeting. He welcomed all the shareholders, auditors and other board members joining over VC. On

request of the chairman all the Directors introduced themselves and confirmed their Respective locations. The requisite quorum being present, the Chairman called the meeting to order.

The Company Secretary gave general instructions to our shareholders. She also informed the Members that pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SERI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had availed remote e-voting facility of Central Depository Services Limited (CDSL) in respect of businesses to be transacted at the Annual General Meeting. The remote e-voting commenced at 9.00 a.m. on Tuesday, September 21, 2021 and ended at 5.00 p.m. on Thursday, September 23, 2021. Company had also provided e-voting facility during the AGM to enable Members to cast their vote who have not casted their vote through remote e-voting. Further, she informed that M/s. Kothari H. & Associates, Practicing Company Secretaries was appointed as the Scrutinizer by the Board for scrutinizing the remote e-voting and the e-voting process. Require quorum was present at the AGM. 94 members were present virtually at the time of AGM including Promoters and Public.

Thereafter, the Chairman gave an overview of the financial performance of the Company for the financial year ended March 31, 2021 and its future outlook. He also briefed about impact of COVID-19 pandemic on the Company.

1. Thereafter, the Chairman informed that M/s. Gupta Saharia & Co, and M/s. Bhatte & Co., Joint Statutory Auditors and Kothari H. & Associates, Secretarial Auditor has expressed unqualified opinion in the respective audit reports for the financial year 2020-201. There were no qualifications, observations or adverse comments on financial statements and matters, which have any material bearing on the functioning of the Company. Hence the same was taken as read.

The Notice of AGM along with Annual Report for the year ended March 31, 2021 and Board's and Auditors' Reports, have been sent by electronic mode to those Members whose e-mail addresses are registered with the Company or Depositories. These documents have also been made available on the Company's website. Considering the above, the Notice is being taken as read.

The following resolutions as set out in the Notice convening the Annual General Meeting were considered and deliberated upon with the forum open for question and answers:

ORDINARY BUSINESSES:

1. Consider and adopt:
 - a. Audited Financial Statement, Reports of the Board of Directors and Auditors
 - b. Audited Consolidated Financial Statement (Ordinary Resolution)

As Mr. Lakhmendra Khurana, Chairman & Managing Director was interested in item no 2 the following item was chaired by Mr. Subir Kumar Banerjee (Independent Director)

2. Re-appointment of Mr. Arpit Khurana who retires by rotation (Ordinary Resolution)

Thereafter Mr. Subir Kumar Banerjee handed over the proceedings back to Mr. Lakhmendra Khurana, Chairman & Managing Director.

SPECIAL BUSINESS

3. Re-appointment of Mr. Subrata Kumar Dey as an Independent Director of the Company.

Thereafter Chairman requested Members to raise query through the facility provided by CDSL at the AGM. The Company had received 4 Speaker Shareholder Request who were given time to Speak at the AGM.


The Chairman thanked all the members for their participation in the meeting. The E-voting facility was kept open for next 30 minutes to enable the Shareholders to cast their vote.

The Chairman informed that the remote e-voting and e-voting results along with Scrutinizer's Report will be notified to the Stock Exchange and also uploaded on the Company's website.

The annual general meeting was concluded at 11.58 a.m.
